

TERMS AND CONDITIONS

I. Eligibility To Play

I.I Dream Boys ('Dream Boys', 'our(s)', 'we') conduct skilled prize competitions at physical location events and on the website www.dreamboys.co.za (referred to as the 'Website'). The competitions result in the allocation of prizes and are subject to the following Terms and Conditions.

I.II People from 18 years and up, and who have reached the age of majority in their country of residence are eligible to play the competitions.

I.III Dream Boys' employees or their immediate family members, or people acting on their behalf, or any other persons who are involved in the creation or administration of our competitions are ineligible to engage in competitions regardless of their age.

II. Promotion Periods

II.I Each competition will have a designated period of time. Please refer to each competition for information on start and end dates and times.

III. Legal Obligation

III.I By entering a competition, you ('participant', 'you', 'your(s)') confirm that you have the legal capacity to do so, have read and understood these Terms and Conditions, and agree to be bound by them, as well as any additional requirements set out in related promotional material.

III.II These competitions are ruled by South African Law and any disputes relating to the competitions will be resolved under South African Law. The Courts of South Africa will have exclusive jurisdiction.

III.III If you partake in a competition on the Website, as well as accept these Terms and Conditions, you confirm that you are not violating any laws in your country of residence regarding the legality of participating in such competitions. Dream Boys will not be held liable for any participant who enters one of our competitions unlawfully. If you are at all uncertain, you should immediately leave the Website and consult with the relevant authorities in your country.

IV. Competition Adjudication

IV.I An independent group of adjudicators appointed by Dream Boys will determine the position of the ball's center after the end of the competition. This will be done using their sporting expertise and in the presence of a Dream Boys representative.

IV.II Within 48 hours after the end of the competition, the Adjudicator's Position will be compared against a database of coordinates to calculate mathematically which of the valid and eligible entries is closest to the Adjudicator's Position, and therefore the winner of the competition. The competition Winner will be the person who correctly identifies, or if no one is correct, the person who is closest to, the Adjudicator's Position. Distance will be calculated as the straight line distance from each valid and eligible Entry to the Adjudicator's Position.

IV.III If there are two or more competitors with valid and eligible entries that are equally close to or exactly match the Adjudicator's Position, the competitors will participate in another spot the ball game to determine the competition winner. This will occur in the following scenarios

IV.IV Dream Boys will use the contact information provided by competitors to attempt to reach the winners, and it is the competitor's responsibility to ensure these details are correct and current.

IV.V If Dream Boys is unable to contact a Winner within 7 days (which may be extended at our discretion) of the end of the competition, or if the Winner fails to accept the prize or contravenes any of the Terms and Conditions, the Winner will forfeit the prize and it will be awarded to the participant with the next closest coordinates. Once the prize has been forfeited, the original winner will have no further claims against Dream Boys.

IV.VI Dream Boys reserves the right to extend the closing date of any competition at its sole discretion, or to suspend, alter or cease a competition, or invalidate any affected entries, if for any reason the competition cannot run as planned due to factors beyond Dream Boys' control. In the event of an early closure of a competition, the Winner may be selected from all valid and eligible entries received by Dream Boys prior to the closure date, but Dream Boys reserves the right to close a competition early without selecting a Winner. If a competition is closed without selecting a Winner, Dream Boys will provide all participants with Credit to replay equivalent tickets in a subsequent competition.

IV.VII All participants will automatically be added to Dream Boys' database for the purpose of conveying information regarding the status of their entry, as well as any future promotions or competitions offered by Dream Boys.

V. Entry to the competition

V.I Competitions can be entered online through the Website, and occasionally at temporary physical locations (such as Seapoint Promenade). The competitions will be of one type ("Spot The Ball") and will have multiple prize options.

V.II The pricing and availability of tickets and competitions is at the will of Dream Boys and will be indicated at the point of sale.

V.III Your Dream Boys Account(s)

To enter a competition, you must register an account with us.

(I) Either register online at www.dreamboys.co.za or in person at a Physical Location.

(i) In order to create an account on our website, you'll need to either provide an email address or sign in using a social media account such as Facebook, Instagram, or Twitter.

(ii) To create an account in person, you'll need to provide an email address.

(II) Please note that your email address or social media account will serve as your username when you log in to your account. Each account can only have one username associated with it at a time (referred to as a "Dream Boys Account"), so you can't have multiple email addresses or social media accounts linked to the same Dream Boys Account. For instance:

(i) You can't have both an email address and a social media account linked to your Dream Boys Account.

(ii) You can't have multiple email addresses linked to your Dream Boys Account. However, you can change your username for your Dream Boys Account by logging in and making the change. For example, you can create your Dream Boys Account using one email address and later change your username to another email address. If you create multiple accounts using different email addresses or social media accounts, each username will be treated as a separate Dream Boys Account.

V.IV To participate in a competition in person, you'll need to:

(I) choose the competition you want to enter, purchase your ticket(s) from a staff member at a stand operated by Dream Boys, and fill out an electronic entry form with your contact information. You'll receive an email receipt with your order details and a link to your registered online account. You'll need to carefully review your details and confirm to Dream Boys' representative that you've read and understood the terms and conditions.

(II) for each ticket you've purchased, you'll need to complete a "Spot the Ball Challenge" onscreen, which works as follows:

(i) you'll be shown a sports photo without a ball;

(ii) using all the information shown in the sports photo on the computer screen, use your skill and judgment to correctly identify the grid square that you believe the adjudicator will determine to be the most likely position for the center of the ball if it were present in the image;

(iii) click on the screen to mark this spot. The computer will register this spot as your entry into the competition.

(III) You can participate in the Spot the Ball Challenge for as many times as you want, up to the set limit. Each entry requires one Ticket.

V.V If playing a competition online through the Website, follow the instructions on the screen to:

(I) select the competition(s) you want to enter, choose your tickets, and play the Spot the Ball Challenge in accordance with 3.4 (b) and (c);

(II) provide your contact and payment information when you are ready to purchase your Ticket(s). Check your information carefully and tick the declaration at checkout to confirm that you have read and understood the competition Terms and Conditions;

(III) We will send you an email to confirm your entry into the competition once your payment has been cleared. Please note that you will not be considered as entered into the competition until we confirm your Ticket(s) order by email.

V.VI Dream Boys reserves the right to reject or disqualify any incomplete entries if it has reasonable grounds to believe that a participant has violated any of these Terms and Conditions.

V.VII To the extent permitted by applicable law, all entries become our property and will not be returned. You acknowledge that you risk losing the value of your entry when playing the Spot the Ball game and that you are completely responsible for any such loss.

V.VIII Entries (tickets) are limited to one-hundred (100) per person, per competition. The abuse of this limit will not be tolerated. If Dream Boys has reasonable grounds to believe that an individual is exceeding this limit, such as entering a competition using multiple accounts, it reserves the right at its sole discretion to void any orders, or to award any prize to the next closest participant. Additionally, if any person using a single account exceeds 100 entries in a single competition for any reason, Dream Boys reserves the right at its sole discretion to void any tickets without notice, first on a chronological basis with respect to orders, and then on a sequential basis with respect to ticket references contained within an order, so as to void any tickets exceeding the first 100 paid tickets entered into the competition.

VI. Competition Prizes

VI.I Each competition will have one and only one prize awarded to the winner.

(I) If, due to circumstances beyond Dream Boys' control, the prize cannot be provided, a substitute prize of equal or greater value may be awarded, or the winner can elect to take the cash alternative.

(II) If the competition winner chooses to receive a prize, Dream Boys will place an order for the selected item.

(III) For South African winners, the prize will be shipped with VAT paid. For winners in other African countries, the prize will be shipped with South African VAT paid, but any additional costs such as VAT, taxes, import duties, or registration fees in the destination country will be the responsibility of the winner. For all other countries, the Prize will be shipped (net of all taxes) to the nearest port, and any further taxes, duties, or registration fees in the destination country will be the responsibility of the winner. Dream Boys may choose not to deliver to certain countries, and winners are responsible for complying with regulations in their destination country. Dream Boys' maximum liability for any prize is the South African RRP as advertised on the website.

(IV) Competition Cash Alternative: If a winner does not wish to receive the Prize, they may opt for the competition Cash Alternative, which is 85% of the South African RRP of the prize(s).

VI.II The Winners are solely responsible for any expenses not specifically mentioned in these Terms and Conditions.

VI.III The Prizes are subject to the Terms and Conditions of the respective prize provider, manufacturer, or supplier.

VI.IV Each Prize must be accepted as awarded and cannot be transferred or substituted for other prizes, vouchers, offers, or discounts, including those provided by Dream Boys or other prize suppliers.

VII. Winner's Personal Data

VII.I Upon accepting the prize, the Winner will be required to have their photo and video taken by Dream Boys for promotional purposes.

VII.II By entering the competition, you agree to the use of your personal information, including your name, address, and photograph or likeness, for publicity events without any additional compensation, except for reasonable travel expenses, as required by Dream Boys if you are declared a Winner.

VIII. Winner's Information

VIII.I Prior to receiving their prize, the winners must provide Dream Boys with a copy of their passport or ID to verify their identity and age, as well as to confirm that they legally owned or had permission to use the credit card used for the purchase. Failure to meet these requirements may result in disqualification and selection of an alternate winner.

VIII.II The winners are also required to provide photographs or agree to be photographed and recorded for future promotional purposes related to the competition, identifying them as a winner.

VIII.III Once Dream Boys has received and verified the necessary details from the winners, arrangements for prize delivery will be made.

IX. Limits of liability

IX.I Dream Boys does not guarantee the quality or suitability of any goods or services offered as prizes. These are guaranteed by the manufacturers thereof. Apart from the liability for death or personal injury caused by Dream Boys' negligence, Dream Boys shall not be liable for any loss suffered or experienced, including consequential (economic) loss, due to any act or omission by Dream Boys or its employees or agents, in connection with the arrangement for supply, or the supply of, any goods by any person to the prize Winner(s) and, where applicable, to any family/persons accompanying the Winner(s), or in connection with any of the competitions promoted by Dream Boys.

X. Electronic Communications

X.I We won't be held responsible for any failed electronic communications from the participant for any reason whatsoever. Dream Boys shall use its best endeavors to award the prize for a competition to the correct participant. If for whatever reason the prize is awarded to the wrong participant, Dream Boys reserves the right to reclaim the competition prize and award it to the correct participant, at its sole discretion and without admission of liability.

X.II Dream Boys reserves the right to extend the closing date of any competition, if for any reason any aspect of the competition is incapable of running as planned, including any cause beyond the control of Dream Boys which corrupts or affects the administration, security, fairness, integrity or proper conduct of the competition. Dream Boys may in its sole discretion cancel, terminate, modify or suspend a competition, or invalidate any affected entries. In the event that Dream Boys closes a competition early, the Winner may be selected from all valid and eligible entries received by Dream Boys prior to the date of closure, except that Dream Boys reserves the right, at its sole discretion, to close a competition early without selecting a Winner. In the event that a competition is closed without selecting a Winner, Dream Boys will give all participants Credit to enable them to replay equivalent tickets in a subsequent competition.

X.III Dream Boys shall not be liable for any economic or other consequential loss suffered or sustained to any persons to whom an award has been incorrectly made, and no compensation shall be due. Dream Boys shall use its best endeavors to ensure that the software and website used to operate its competitions perform correctly and accurately across the latest versions of popular internet, tablet and mobile browsers. For the avoidance of doubt, only the ticket coordinates recorded in our systems, howsoever displayed or calculated, shall be entered into the relevant competition and Dream Boys shall not be held liable for any competition entries that occur as a result of malfunctioning software or other event.

XI. Data Protection Notice

XI.1 Any personal data that you supply to Dream Boys or authorize Dream Boys to obtain from a third party, for example, a credit card company, will be used by Dream Boys to administer the competition and fulfil prizes where applicable. In order to process, record and use your personal data Dream Boys may disclose it to any credit card company whose name you give, any person to whom Dream Boys proposes to transfer its business or any part of it, any person to whom Dream Boys proposes to transfer any of Dream Boys' rights and/or responsibilities under any agreement Dream Boys may have with you, comply with any legal or regulatory requirement of Dream Boys in any country, prevent, detect or prosecute fraud and other crime. In order to process, use, record and disclose your personal data Dream Boys may need to transfer such information outside South Africa, in which event Dream Boys is responsible for ensuring that your personal data continues to be adequately protected during the course of such transfer.
